OBJECTIVES

- 1. Discuss the role of the Quality Director in educating and informing front-line staff and board members about quality.
- 2. Recognize ways hospitals can adopt a culture of quality to foster continuous quality improvement and promote staff engagement across all aspects of the organization.
- 3. Analyze current practices and create ways for every position to be committed to quality.
- 4. Describe why participating in a Culture of Safety Survey is Important.
- 5. List 3 strategies for a successful Culture of Safety Survey.
- 6. Interpret the definition of an impaired healthcare provider, types, identification, and scope of the problem.
- 7. Recognize what a Monitoring/Alternative to Discipline program is and provides.
- 8. Identify how COVID has led to a decrease in referrals of impaired providers and what's at risk.
- 9. Identify the different type of subpoenas, e.g., subpoena for business records, medical records, documents, depositions, etc., and identify what matters.
- 10. List the first three things one should do upon receiving a subpoena or demand letter to protect their hospital's interests.
- 11. Receive sample policies and procedures that will save time while still protecting their hospital's interests.
- 12. Receive "inside tips" on what one can do internally to help reduce the legal costs associated with subpoena management.
