Legislative Post Audit Recommends Lay-Giver Legislation

The Legislative Post Audit Committee, chaired by Sen. Caryn Tyson (R-Parker), met yesterday. The committee, which had previously sought an audit on behalf of Rep. Jason Probst (D-Hutchinson) to ensure compliance of hospitals to the state Lay Caregiver Act, has now decided rather than a post audit to seek the introduction of legislation on the topic. The proposed legislation would amend the Lay Caregiver Act in <u>KSA 65-431 A</u> to require the Kansas Department of Health and Environment to verify each hospital complies with the Lay Caregiver Act, conduct an annual compliance audit, compile results, and report to the health committees annually. The legislation will be introduced during the 2025 state legislative session slated to begin on Jan. 13.

The legislative session, scheduled to begin on Jan. 13, looks to be a quick session based on the legislative schedule released by leadership. The schedule includes the following deadlines:

- Jan. 13: First Day of 2025 Session
 Jan. 27: Last Day for individuals to request member-sponsored bill drafts
 Feb. 3: Last day for non-exempt committees to request bill drafts
 Feb. 5: Last day for individual bill introductions in the chamber
 Feb. 7: Last day for non-exempt committee bill introductions in the chamber
 Feb. 17: Last day for non-exempt committees to meet before Turnaround
 Feb. 18-20: Floor Work All Day
 Feb. 20: Turnaround Day
 Feb. 21-24: No Session
 March 18: Last day non-exempt committees to meet to consider bills
- March 19-21: Floor Work All Day

March 21: Last day for non-exempt bills in either Chamber March 29-April 9: Legislatures Not In Session for April Break April 10-April 12: Veto Session
