President's Perspective – Healthworks Serves Valuable Role for Kansas Hospitals

Since 1969, the Kansas Hospital Association's foundation, Healthworks, has played an important role in supporting its mission and vision. While Healthworks shares the same vision of KHA, "Optimal Health for Kansans," its specific mission is to "facilitate collaboration and innovation to improve health." Healthworks strives to accomplish this in a variety of ways. For the current year, the main priority focus of Healthworks falls within three areas:

- Health care delivery redesign
- Workforce supply and capacity
- Grant support

The Healthworks brand is likely recognizable to you; however, you may not know the breadth and scope of the resources it provides to support Kansas hospitals. As part of its portfolio, Healthworks has been the lead organization supporting QHi, the multi-state, web-based benchmarking tool designed by small rural hospitals and clinics to give executives insight into clinical quality, finance, operations, workforce and patient satisfaction. At present, QHi is being used by 428 hospitals in 12 states. Other Healthworks efforts include the Kansas Health-e Broadband project and multiple projects with Kansas Rural Hospitals Optimizing Performance, known as KRHOP.

A few Healthworks projects I would like to spotlight include its role in helping Kansas hospitals build a sustainable workforce, as well as its work in the area of new models of care. Developing a sustainable, and knowledgeable, workforce pipeline continues to be a primary focus for Healthworks. It works on this goal through many initiatives including the Healthworks longstanding health care scholarships program, now in its 22nd year, as well as newer initiatives, such as support for the Kansas Health Care Virtual Career Day and funding for HOSA-Future Health Professional student chapters in Kansas. These types of workforce initiatives are exposing high school students, and young professionals, to the rewarding aspects of choosing a career in health care. Another important project Healthworks has been leading for several years includes the exploration of new health care delivery models. While the work in this area has been ongoing for many years, the results of its efforts are starting to be realized. Early on, hospital leaders around Kansas engaged in discussions on developing new and sustainable models of care for rural communities. Initially referred to as a Primary Health Center model, the ideas and concepts gained traction and are largely incorporated into what is now the Rural Emergency Hospital model. Kansas is now home to two Rural Emergency Hospitals, located in Arkansas City (SCK Health) and Moundridge (Mercy Hospital, Inc). Nationwide, this new delivery model has been replicated in more than 20 locations. Healthworks continues to play an important role in this new delivery model by having Jennifer Findley, Healthworks executive director, serving on the National Technical Center's Advisory Committee.

While it takes a talented and dedicated Healthworks team to carry out the projects and initiatives, it also requires visionary leadership from the Healthworks Board of Directors. I want to specifically express my appreciation for the board's leadership and commitment to the vision and mission of Healthworks. The 2024 Healthworks Board is led by Eddie Hermann, Hays Medical Center, Hays (chair), Todd Willert, Community HealthCare System, Inc., Onaga (vice chair) and current board members include Austin Gillard, Clay County Medical Center, Clay Center; Dee Dee Dewell, Pioneer Health Network, Garden City; Ken Johnson, Wichita; Patrick Custer, Morton County Health System; Elkhart; Brian Lawrence, Coffeyville Regional Medical Center, Coffeyville; Stephanie Bjornstad, Rooks County Health Center, Plainville; Claudio Ferraro, Ascension Via Christi Hospitals, Wichita; Janell Goodno, Kiowa District Hospital, Kiowa; and Robert Durrett, DO, Kansas COM, Wichita. Be on the lookout for a new Healthworks project launching very soon. This initiative will provide tools and resources to assist hospitals in finding and writing grants to support projects at the local level.

Register Now for the U.S. Drug Supply Chain Security Act Requirements Webinar – Mar. 28

The U.S. Drug Supply Chain Security Act, signed into law in 2013, is designed to track and trace prescription drugs distributed in the U.S. from the manufacturer to the point of dispensing to the patient. In August 2023, the Food and Drug Administration announced a one-year "stabilization period" for DSCSA requirements that became effective Nov. 27, 2023. The FDA stabilization period was intended to accommodate the additional time needed to comply with DSCSA requirements. The FDA will begin enforcing the DSCSA in November 2024.

Building a Systemic Well-Being Program: A 5-Step Blueprint

The American Hospital Association Physician Alliance partnered with the Collaborative for Healing and Renewal in Medicine to develop a resource for Building a Well-Being Program. The resource outlines, in five steps, how hospitals and systems can create a well-being program, presents the business case for why hospitals and health systems should address burnout and the impact of burnout on quality and patient safety. Funding Opportunity for Rural Opioid Response – Apply by May 6

Continuing the Rural Communities Opioid Response Program, the Health Resources and Services Administration plans to make approximately 16 awards under <u>RCORP-Impact</u> to improve access to integrated, coordinated treatment and recovery services for substance use disorder, including opioid use disorder, in rural areas.

The <u>Notice of Funding Announcement for RCORP-Impact</u> was released on <u>Grants.gov</u> this week. Applications are due on May 6. Funds may only support activities in <u>HRSA-designated rural</u> <u>areas</u>. Applicants must apply as part of a network that includes at least four entities (three entities plus the applicant organization). At least 50 percent of these entities must be located within the target rural service area. Each grantee will receive up to \$750,000 per year for a four-year project that meets four goals, including service delivery, workforce, supportive services and sustainability.

All RCORP-Impact award recipients are required to provide medication for opioid use disorder, but otherwise the program allows flexibility at the local level to meet the four goals while addressing needs unique to each community. Grantees also may be able to build their local workforce through one of <u>HRSA's loan repayment programs</u> for the National Health Service Corps. Clinicians who receive these payments must agree to work a minimum number of years at <u>approved sites in underserved and rural areas</u>.

Kansas Connecting Communities Free Program and Resources to Support Maternal Mental Health

Kansas Connecting Communities is a federally funded behavioral health workforce development program administered by the Kansas Department of Health and Environment. KCC supports health professionals in Kansas in identifying and addressing mental health concerns of individuals during and after pregnancy and was renewed for another five years.

KCC provides a <u>Perinatal Provider Consultation Line for Behavioral Health</u>, a free consultation line available to providers working in or serving patients in Kansas. Through the line, professionals can get practitioner-to-practitioner consultations, resource and referral assistance and access to training, including CE and technical assistance, at no cost. Additionally, through a partnership with Kansas Connecting Communities, the Kansas Chapter of Postpartum Support International is offering training scholarships to Kansas professionals working with perinatal populations or those interested in advancing their expertise in perinatal mental health.

Health Equity Services Covered in Medicare's 2024 Physician Fee Schedule Final Rule In the calendar year 2024 Physician Fee Schedule rule, the Centers for Medicare & Medicaid Services finalized several new services addressing health equity, including:

- Caregiver training services
- Social determinants of health risk assessment
- Community health integration
- Principal illness navigation services

CMS released guidance on these services available to Medicare beneficiaries and codes for providers in a new <u>Medicare Learning Network booklet</u>. --Karen Braman

Federal and National News

Older Adults Now Able to Receive Additional Dose of Updated COVID-19 Vaccine

Last week, the Centers for Disease Control and Prevention endorsed the CDC Advisory Committee on Immunization Practices' recommendation for adults ages 65 years and older to receive an additional updated 2023-2024 COVID-19 vaccine dose. The recommendation acknowledges the increased risk of severe disease from COVID-19 in older adults, along with the currently available data on vaccine effectiveness. HHS Issues Statement Regarding the Cyberattack on Change Healthcare

Change Healthcare is involved in a recent cybersecurity attack, causing delays in prior authorization determinations, claims filing and payment administration. The U.S. Department of Health and Human Services released a <u>statement</u> to inform affected parties about flexibilities in place to assist with timely payments to providers. The statement includes information from the Centers for Medicare & Medicaid Services related to changing clearinghouses, guidance for Medicare Advantage organizations and Medicaid managed care plans to remove or relax prior authorization processes, and assistance for providers who are having trouble filing claims. Optum provided <u>information</u> about a funding assistance program intended to help Change Healthcare customers who were impacted by the recent payer system outage.

OMB Set to Review LTCF Minimum Staffing Rule

The Centers for Medicare & Medicaid Services <u>submitted</u> the Minimum Staffing Standards for Long-Term Care Facilities and Medicaid Institutional Payment Transparency Reporting <u>proposed</u> <u>rule</u> to the Office of Management and Budget for review. The final rule could be published at any time.

CDC Shares Additional Respiratory Viral Illness Guidance Information

The Centers for Disease Control and Prevention shared <u>additional information</u> about the <u>updated guidance</u> for respiratory viral illness discussing how people can protect themselves and their communities from respiratory viruses, including COVID-19. The CDC updated its recommendations because the U.S. is seeing fewer hospitalizations and deaths associated with COVID-19, and because there are tools available to combat flu, COVID and RSV.

CMS Issues Final Guidance on Medicare Prescription Payment Plan

The Centers for Medicare & Medicaid Services <u>released</u> a final part one <u>guidance</u> for the new Medicare Prescription Payment Plan. The guidance addresses topics such as identifying Medicare Part D enrollees who are likely to benefit from the program, the opt-in process, program participant protections and the data collection needed to evaluate the program. The guidance requires pharmacies to provide information about the program for anyone who meets a \$600 out-of-pocket threshold based on a single prescription at the point of sale. Medicare Part D enrollees will be able to opt into the new <u>program</u> for the <u>2025 plan year</u>.

TJC Reminds Hospitals of CY 2023 Reporting Deadlines

The deadlines for accredited acute care, critical access and freestanding psychiatric hospitals to submit calendar year 2023 ORYX[®] performance measure data via The Joint Commission's Direct Data Submission Platform are as follows:

- Friday, Mar. 15 Organizations required or electing to submit electronic clinical quality measures must upload, verify and submit all four quarters of calendar year 2023.
- Sunday, Mar. 31 Organizations required or electing to submit chart-abstracted measure data must enter and submit fourth-quarter 2023 data.
