### Abbvie and AstraZeneca Challenge Kansas 340B Protections

Pharmaceutical companies Abbvie and AstraZeneca filed separate lawsuits on July 1 against Kansas Attorney General Kris Kobach over the 340B protections passed during the 2024 legislative session.

During the legislative session, the Kansas Legislature approved a budget proviso requiring drug manufacturers to honor 340B pricing at contract pharmacies under the Consumer Protection Act of Kansas. The lawsuits seek to prohibit Attorney General Kobach from enforcing violations of the Kansas Consumer Protection Act by drug manufacturers enrolled in the 340B federal drug discount program.

The 340B program requires drug manufacturers to sell outpatient drugs at a discount to safety-net providers, including certain designated hospitals serving high numbers of low-income Medicare, Medicaid and Supplemental Security Insurance patients. Congress created the program in 1992 to extend to safety-net providers the same kind of relief from high drug costs that Congress provided to the Medicaid program with the Medicaid rebate law, allowing these providers to "stretch scarce federal resources as far as possible, reaching more eligible patients and providing more comprehensive services."

The Kansas Hospital Association is in close communication with the AG's office and works closely with the American Hospital Association, legal counsel and partners such as the Community Care Network of Kansas, Kansas Council of Health System Pharmacists and Kansas Pharmacists Association to defend 340B protections in Kansas.

Many members responded to a recent survey on the impact of pharmaceutical manufacturers' 340B contract pharmacy limitations—thank you for your quick response! KHA may continue to seek information from member hospitals as necessary to demonstrate the importance of the 340B program. Thank you for your ongoing support as we fight to protect 340B in Kansas.

#### Noon Briefing: Addressing Transportation Challenges that Impact Health – July 31

Transportation is a significant social driver of health. The lack of consistent, reliable transportation and the physical environment that enables or is a barrier to active transportation have health implications for individuals and communities.

Transportation is key in accessing a range of opportunities, services and products, such as employment, education, healthy foods and health care services, among others. Transportation in rural communities presents unique challenges because of the geographic distances rural community members must travel to meet many health care, social and occupational needs. Additionally, transportation challenges may increase health disparities and health inequities. These disparities may be disproportionately felt by populations with special health needs, low socioeconomic resources, older adults, people of color and immigrant populations living in rural areas.

Join us for a free webinar at noon on July 31, highlighting strategies used by communities across Kansas to tackle transportation challenges that impact health. In addition, learn about Kansas Mobility Management, a public transportation strategy sponsored by the Kansas Department of Transportation, that develops and facilitates coordination strategies benefitting both passengers and the transit providers that serve them.

# 2024 Fall Safe Sleep Instructor Training – Sept. 26-27

The Kansas Infant Death and SIDS Network invites you to apply for the <u>14th Biannual Safe Sleep</u> Instructor Certification training, Thursday and Friday, Sept. 26-27, in Wichita.

The KIDS Network SSI Certification aims to prepare instructors to consistently educate parents/caregivers, childcare providers, health care providers and other community members about safe infant sleep practices through standardized training and community outreach. The KIDS Network SSI Certification training has certified more than 300 Safe Sleep instructors and trained more than 6,000 professionals and more than 4,000 families. These trainings have resulted in significant increases in knowledge of the AAP Safe Sleep recommendations and intentions of parents/caregivers to follow the AAP recommendations. In addition, eight hospitals have engaged in the Cribs for KIDS National Safe Sleep Hospital Certification, and 13 clinics have engaged in the KIDS Network Safe Sleep Star Outpatient Clinic Certification.

Participating in this train-the-trainer program will allow you, or someone from your organization, to serve as a champion in your community, providing evidence-based interventions to reduce infant mortality. ### **Federal Court Blocks FTC Ban on Noncompete Contracts**

On July 3, the U.S. District Court for the Northern District of Texas in *Ryan LLC V. Federal Trade Commission* issued a preliminary injunction to stop the Federal Trade Commission from enforcing its non-compete rule which, absent the order, would go into effect on Sept. 4, 2024. The rule prohibits nearly all employee non-compete agreements with limited exceptions. The court's order prohibits the FTC from enforcing the rule against the plaintiffs until it makes its final decision on or before Aug. 30, 2024. With another federal court case pending in Pennsylvania challenging the rule and additional legal challenges expected to make their way through the U.S. Court of Appeals and potentially the U.S. Supreme Court, it may be some time before the ability of the FTC to enforce the non-compete rule is decided.

# **Federal and National News**

### **CMS Issues LTCF Data Guidance**

The Centers for Medicare & Medicaid Services issued <u>guidance</u> for long-term care facilities on data collection and publication, specifically related to new staffing requirements and methodology. CMS lists additional resources for facilities, clarifies calculating turnover rates and provides information on how data will be displayed, among other information contained in the guidance.

#### **New Rural Substance Use Disorder Information Center**

The Federal Office of Rural Health Policy has announced a new Rural Substance Use Disorder Info Center. This new clearinghouse highlights the work of three different Rural Centers of Excellence on Substance Use Disorders, all funded by FORHP's Rural Communities Opioid Response Program. Visitors to the website will find current information and technical assistance opportunities on SUD through a rural lens.

# CDC Updates Vaccine Guidance for 2024-2025 Respiratory Virus Season

As of June 26, the Centers for Disease Control and Prevention <u>recommends</u> that everyone over age 75 and individuals at increased risk for severe RSV receive the RSV vaccine. This recommendation is for people who did not receive an RSV vaccine last year; at this time, the RSV vaccine is not an annual vaccine. The best time for vaccination is in late summer or early fall before RSV starts to spread. Recommendations for pregnant people, infants and young children were not changed. The CDC's updated guidance for <u>RSV vaccinations</u> provides additional clinical details.

On June 27, the CDC <u>updated recommendations</u> for COVID-19 and influenza vaccines to recommend everyone age six months and older receive updated 2024-2025 COVID-19 and influenza vaccines. COVID-19 vaccine recommendations will take effect later this year when updated Moderna, Pfizer and Novavax COVID-19 vaccines are available. Most people are recommended to get the flu vaccine in September or October. Guidance for <u>COVID-19</u> <u>vaccines</u> and <u>flu vaccines</u> will be updated soon and will provide additional clinical details.

## CMS Releases Proposed Medicare CY 2025 OPPS and ASC Payment and Policy Updates

The Centers for Medicare & Medicaid Services <u>released</u> the proposed Medicare Outpatient Prospective Payment System and Ambulatory Surgical Center payment and policy <u>updates</u> for calendar year 2025. Medicare OPPS and ASC payment rates are estimated to increase by 2.6 percent. The proposed rule includes new <u>policies</u> "that aim to reduce maternal mortality and morbidity, which disproportionally affect underserved communities." CMS will accept comments on the proposed rule through Monday, Sept. 9.

## **CMS Releases Home Health PPS Proposed Rule**

The Centers for Medicare & Medicaid Services <u>released</u> a proposed rule to mitigate the impact of significant, anomalous and highly suspect billing activity on Medicare Shared Savings Program financial calculations for calendar year 2023. CMS determined that two specific HCPCS codes displayed as significant, anomalous and highly suspect billing activity, consisting of A4352 – intermittent urinary catheter and A4353 – intermittent urinary catheter, with insertion supplies. CMS noted that absent mitigation measures, the SAHS billing activity would inflate Medicare Parts A and B spending. CMS will accept comments on the proposed rule through Monday, July 29.

• The Centers for Disease Control and Prevention will host a <u>Clinician Outreach and Communication Activity call</u>, providing an update on the Highly Pathogenic Avian Influenza, or H5N1, virus at 1 p.m. Tuesday, July 16. During this call, attendees will receive an update on the outbreak in the U.S. and current CDC surveillance and monitoring efforts. Clinicians who attend will learn about testing, using antivirals and infection prevention and control recommendations.
