President's Perspective – Exemplary Trustees to Be Recognized at the KHA Convention

These trustees will be recognized during the KHA Awards Ceremony on Sept. 5, 2024, in Overland Park. Here is a little more about these exceptional leaders:

Terry David has served on the board at Hospital District #1 of Rice County for 21 years. He has served as Chairman, Vice-Chairman, Secretary and Treasurer. Terry fosters collaboration between the board, administration and medical staff and has been pivotal in strengthening the relationships with other local health care partners. In addition, Terry has been recognized as an advocate for communities by serving as a county commissioner. Through his leadership on the commission, Terry has brought structure and level-headed governance that has allowed for business growth opportunities and collaboration between the county and local city governments. Terry's leadership style can be characterized as "leading by example." He doesn't give direction or guidance from the sidelines but fully immerses himself in the task or project.

Jared Estes has served on the board at Via Christi Rehabilitation Hospital for nine years. Jared brought a unique patient perspective to board governance and board discussions. As a young man, Jared was involved in a tragic car accident that killed his wife and left him with burns on more than half of his body. This terrible event turned him into an advocate for burn patients and rehab services. He now tours the country, speaking on behalf of this vulnerable patient population wherever he can raise his voice. His message has been spread through schools, hospitals and other organizations. His purpose as a motivational speaker shedding light on these patients is fueled by a goal to decrease their suicide and alcohol-related deaths.

Matt Floersch, MD, has served on the board of Ascension Via Christi Hospital Manhattan, Inc., for eight years. He has served as chairman, vice-chairman, secretary and treasurer. Dr. Floersch has led partnership discussions, assisted with evaluating acquisitions and program changes and is a consistent voice of calm and reason as the hospital navigates operational challenges. He advocates for the community and strongly encourages collaboration with entities like Konza Prairie (FQHC), Pawnee Mental Health Services and other providers. Dr. Floersch is well respected by his peers. He is seen as collaborative, fair and focused on the greater good. Additionally, he is the medical director for Meadowlark, a local senior community and has distinguished himself for his care of the elderly and willingness to focus on geriatric care.

Debbie Palacioz has served on the board at NMC Health for 12 years. She has a proven track record of leadership and service in the community. During board meetings, Debbie is fully present and engaged. Her unwavering personal values speak volumes when the board considers current and future actions. While defending the mission, vision and values of the hospital, she is inquisitive and sensitive about how the hospital's work and relationships serve hospital constituents. She asks the hard questions. She is part of a board that ensures a generous financial assistance program. She supports the hospital's relationships with community partners in a way that protects the interests of all concerned. Integrity is her watchword, and she is highly respected as a result.

Dan Palmgren has served on the Satanta District Hospital, Clinics & LTCU Board for 24 years. Dan is a small business owner and has been a pillar of the Satanta community since 1983. His leadership extends to the Satanta District Hospital Board, where he has been the board chair since January 2018. Dan's business knowledge and unwavering commitment to his community have provided exceptional leadership to the SDH Board. You will not find a stronger advocate for local health care than Dan. Health care is not always glamorous. Sometimes, you must make difficult decisions that the public may or may not understand. Dan and the SDH Board work hard to ensure every decision is not only in the best interest of the hospital but also the community in which they serve.

In the future, Dee Lewis will place all financial impact reports in the HIDI Analytical Advantage site for hospitals to receive. New reports loaded to the site include the Calendar Year 2025 Outpatient Prospective Payment System Proposed Rule Impact Report, Fiscal Year 2025 Inpatient Psychiatric Facility Proposed Rule Impact Report, First Quarter 2024 Financial Indicators Report and the Critical Access and Small PPS Hospitals Utilization Analysis. We will inform hospitals when new impact reports are loaded to the site.

HRSA Grants Available for Expanding Physician Residency Program

The Health Resources and Services Administration has released a new funding opportunity to expand existing approved physician residency programs and establish new approved programs.

The <u>Teaching Health Center Graduate Medical Education Program</u> trains physicians and dentists, in community-based settings, focusing on rural and underserved areas. This unique training model provides most of the training in community-based outpatient settings where most people receive their health care.

One component supports residency slots starting in the academic year 2024-2025 and another component for 2025-2026. \$10 million is available for the 2024-2025 academic year, while \$80 million is available for the 2025-2026 academic year. Applications for each component are due Sept. 5 and Sept. 20.

Eligible applicants include teaching health centers, Teaching Health Center Planning and Development grant recipients who have obtained accreditation and other programs that plan to be accredited and train residents starting July 1, 2025.

Grant funds can be used to support direct and indirect expenses associated with sponsoring approved graduate medical education residency programs, including increasing the number of full-time employee residents in an existing residency program.

Advanced Nursing Education Workforce: Grow and Stay Grant Program

Grant funding is available for Kansas nurses attending or interested in attending graduate nursing programs at the University of Kansas School of Nursing.

The Advanced Nursing Education Workforce Grow and Stay program, funded by The Health Resources and Services Administration and administered by the University of Kansas School of Nursing, is designed to enhance and increase the nursing workforce in Kansas. ANEW provides eligible nurses with a financial award of up to \$25,000 for full-time study and \$15,000 for part-time study.

Eligible candidates must be enrolled in a clinical practicum course in one of the following BSN-DNP or post-master certificate programs:

- Family Nurse Practitioner
- Psych-Mental Health Nurse Practitioner
- Nurse-Midwife

Funding can be used to cover tuition and other related expenses. For more information, visit the ANEW: Grow and Stay website.

KDHE Announces Changes Coming to Hepatitis B Birth Dose Program

The Kansas Department of Health and Environment notified birthing hospitals recently that the Hepatitis B Birth Dose program, supported by "317" federal funds, will sunset this fall. Moving forward, Hepatitis B vaccine and nirsevimab will be provided through the Vaccines for Children program. In their announcement, KDHE shared the reason for the transition is that the Centers for Disease Control and Prevention is ending the Hepatitis B Birth Dose Program due to VFC funding availability. KDHE requests all birthing hospitals complete this survey to express interest in transitioning to the VFC Program. Regional Immunization Nurses with KDHE are available to support birthing hospitals during this transition. For questions, please email KDHE.IMMconsultant@ks.gov.

KHA HIDI Advantage Optics Update and HIDI Academy Learning

Advantage Optics, the online reporting tool accessed from the HIDI Advantage User Portal, is where your KHA hospital-level data resides. This week, the site was updated with the May 2024 data and now contains October 2018 – May 2024 inpatient, outpatient and emergency department discharges. This includes Executive Snapshot Dashboards, located under Market Optics.

As a reminder, HIDI recently launched the HIDI Academy. This new service enhances users' learning experience by providing access to HIDI-specific Market Optics training modules and resources through a user-friendly interface.

Kansas Fights Addiction Grant Program – Deadline to Apply Is Aug. 2

A third round of funding to support substance use disorder services across the state is now available through the Kansas Fights Addiction grant program. The funding comes from money the state recovers through opioid legal settlements and will be made available through a Request for Proposal grant application process. This third RFP, similar to the first round of KFA funding in 2023, prioritizes strategies related to treatment, recovery, harm reduction and linkages to care established by the Kansas Prescription Drug and Opioid Advisory Committee in its 2023-2027 state strategic plan. Eligible organizations include state agencies, local and county governments, and nonprofit organizations providing services in Kansas to prevent, reduce, treat or otherwise abate or remediate SUDs. To be eligible, applicants also must release all legal claims arising from covered conduct against each defendant named in the opioid settlement agreements. Organizations may apply for up to \$300,000 in grant funding through this third RFP, with each grant having a 12-month budget period. For more information and to download the RFP, click here.

Tips for Registering Online for the KHA Convention and Trade Show

Federal and National News

GAO Report Recommends Strengthened Oversight of State's Medicaid Eligibility Review Practices

A <u>Government Accountability Office report</u> reviews state practices relating to Medicaid eligibility verification and documents the significant shortcomings common to several states. The GAO recommends that the Centers for Medicare & Medicaid Services document and implement the oversight practices the agency learned during unwinding, which were needed to prevent and detect state compliance issues with redetermination requirements.

CDC Issues Health Advisory about Disruptions in Availability of Blood Culture Bottles

The CDC issued a <u>health advisory</u> regarding the disruptions in the availability of Becton Dickinson BACTEC™ blood culture bottles. The advisory includes recommended steps for facilities impacted by this shortage and <u>resources</u> for prioritizing blood cultures in both pediatric and adult populations.

In addition, the Infectious Disease Society of America held a <u>clinician call</u>, which covered insights into how facilities are addressing the bottle shortage.
