Fraud Alert Issued Regarding Suspect Payments in MA and Provider Marketing Arrangements

The Office of Inspector General of the U.S. Department of Health and Human Services has issued a special fraud alert to warn health care and insurance-related entities about certain fraud and abuse risks associated with marketing arrangements between Medicare Advantage Organizations and health care professionals and arrangements between HCPs and agents and brokers for Medicare Advantage plans.

These marketing arrangements involve questionable payments and referrals between MAOs, HCPs and third-party marketers that can mislead Medicare enrollees into choosing specific health plans or health care providers that may not meet the enrollees' needs. The OIG is concerned that parties involved may skew the guidance they provide to MA enrollees based on the parties' respective self-interests.

A significant risk area cited in the alert involves MAOs paying remuneration to HCPs, such as gift cards, for HCPs referring to or recommending patients to enroll in a particular MA plan. Additionally, the OIG highlights payments of concern from HCPs to agents and brokers in exchange for agents/brokers recommending that HCP be sent to a particular MA enrollee or referring the enrollee to the HCP.

KHC and KHA Release Issue Briefs on Emergency Department Visits for Asthma in Kansas

The Kansas Healthcare Collaborative and the Kansas Hospital Association partnered on a <u>series of issue briefs on Emergency Department visits</u> in Kansas, using the Agency for Healthcare Research and Quality Emergency Department Prevention Quality Indicators. This brief, Emergency Department Visits for Asthma in Kansas, FY23, is the fourth in the series. In September 2023, AHRQ released a new group of area-based quality measures called Emergency Department Prevention Quality Indicators. Five PQE measures reflect ED visit rates for potentially preventable ED visits. The PQEs are area-based measures, meaning they are evaluated and reported for geographic areas, usually counties. The PQEs are "avoidable use" measures in that they identify conditions sensitive to the health status of a county's population (or other area) and the availability and quality of health care services in the county. PQEs are not used to measure quality at the hospital level.

KHA and KHC hope the results of these issue briefs are useful to hospitals and other organizations planning population health improvement activities, community health needs assessments or other health improvement efforts.

Updates to the KHA Discharge Data Submission Program

The Kansas Hospital Associations Data Committee has approved the <u>expansion of payer codes</u> and the submission of language spoken within the discharge data reporting program. A list of the expanded payer codes is <u>available here</u>. Language spoken will be included in Report Type G, new to the submission format. An updated data submission instruction, timeline and format is <u>available here</u>. Hospitals are encouraged to begin reporting as soon as possible. We hope to have all facilities reporting by July discharges (due Sept. 15, 2025).

We understand that these changes will require modifications to established data submission processes and appreciate KHA hospital's commitment to advancing our hospital data collection and analytics. CMS Releases CY 2026 Medicare Advantage Proposed Rule

On Nov. 27, the Centers for Medicare & Medicaid Services released the contract year 2026 Medicare Advantage and Part D Policy and technical changes <u>proposed rule</u>. The proposed rule increases oversight and improves accountability of Medicare Advantage plans while also improving protections of Medicare beneficiaries.

KHA has prepared a summary of the significant provisions that can be <u>viewed here</u>. Key highlights of the proposed rule include:

- Permit coverage of anti-obesity medications in the Medicare and Medicaid programs.
- Fortify existing limitations on insurer use of internal coverage criteria and requirements for MA plans to provide coverage for all reasonable and necessary Medicare Part A and B benefits.
- Update MA and Part D plan medical loss ratio reporting requirements to improve oversight.
- Require MA plans to make provider directory information more widely available through the Medicare Plan Finder tool.
- Improve transparency through increased oversight of agent and broker materials and marketing from MA plans.
- Limit enrollee cost sharing for behavioral health services to an amount that is no greater than Traditional Medicare.
- Apply additional guardrails of insurer use of artificial intelligence to ensure it does not result in inequitable treatment or access to care.

Kansas Moms in Mind Consultation Clinic Series

The series allows physicians and other health care providers to connect with peers and gain knowledge on various topics related to the medical management of psychiatric disorders in the perinatal period. Each clinic features a brief didactic and collaborative case review. Register for information about the entire series and join individual clinics as you are available. Presenters are Erin Bider, MD, a perinatal psychiatrist, and Tara Chettiar, MD, FACOG, an OB/GYN and certified perinatal mental health (PMH-C) provider, both based at the University of Kansas Health System. The clinics occur at noon on Feb 11, Apr 8, Jun 10, Aug 12 and Oct 14.



These clinics are intended to provide evidence-based education and support from trained professionals. Decisions around medication in the perinatal period should always involve an individual risk-benefit analysis and discussion with the pregnant person and their partner/family about treatment options, especially concerns for the fetus or baby. Federal and National News

PREP Act Extended Allowing Pharmacists to Administer COVID-19 and Flu Vaccines to Children Ages Three and Up

On Dec. 11, the U.S. Department of Health and Human Services on Dec. 11 <u>extended the PREP Act</u>, allowing pharmacies to continue administering COVID-19 tests, as well as administering COVID-19 and influenza vaccinations to ages three years and older. The extension is valid through Dec. 31, 2029. The age limit for vaccines other than COVID-19 and flu administered in Kansas pharmacies is still subject to state statute, which is 12 years and older.

HRSA Announces Funding Opportunity for Behavioral Health Workforce

The Health Resources and Services Administration released a new Notice of Funding Opportunity to increase the number of highly trained behavioral health providers nationwide. HRSA will award one cooperative agreement of approximately \$2.5 million annually over four years.

The <u>Behavioral Health Workforce Development Technical Assistance Program</u> aims to provide tailored technical assistance to current and future HRSA-funded programs. View the <u>funding opportunity</u> for complete eligibility information. Applications are due Monday, March 3, 2025.

MACPAC Releases 2024 Edition of MACStats

The Medicaid and Children's Health Insurance Plan Payment and Access Commission <u>published</u> the <u>2024 MACStats Databook</u>. The databook compiles updated data on national and state Medicaid and CHIP enrollment, spending, benefits, beneficiaries' health, service use and access to care.
