Swing Bed Basics

Carolyn St. Charles, Chief Clinical Officer, HealthTech

The Swing Bed regulatory requirements have not changed much since 2020, with the exception of the content of the discharge notice. The presentation will provide an overview of Swing Bed regulatory requirements and interpretive guidelines, including admission assessment, multi-disciplinary plan of care, therapy services, nutrition, medication management including psychotropic drugs and activities.

- Describe regulatory requirements for the multi-disciplinary plan of care, therapy services, and nutrition.
- List at least two (2) ways for providing and documenting activities.

Swing Bed Admission, Criteria for Continued Stay and Discharge

Carolyn St. Charles, Chief Clinical Officer, HealthTech

Admission to Swing Bed for patients with traditional Medicare must meet specific criteria as defined by Medicare, including a 3-day qualifying stay within the last 30 days. However, organizations may also have their own criteria based on the type of patients they can accept. The presentation will review Medicare criteria, including rules for when the patient has been a patient in more than one hospital.

After the patient is admitted to the swing bed, there must be a continued skill need. Sometimes, the swing bed team has differing opinions about when a patient should be discharged. The presentation will include guidelines and discussion points for helping the Swing Bed team determine when the patient is ready for discharge, as well as patient-required discharge notices.

- Describe at least two Medicare criteria for admission to Swing Bed, including when the time from hospital discharge to swing bed admission can exceed 30 days.
- Identify continued stay criteria.
- Explain discharge documentation requirements.

Social Determinants of Health: A Journey of Trials, Innovation and the Pursuit of Enhanced Patient Outcomes

This information sharing session details the journey and methodology of a small Critical Access Hospital's (CAH) Swing Bed Program pathway to enhancing practices to better meet SDOH individual needs of their rural Kansas population. The presentation team will highlight the transition from current practices that address SDOH unmet needs to alignment with regulatory and industry standards. The Swing Bed discharge planning process is a team approach from the Care Coordination Team, the Hospitalist and others to set the patient and family up for success upon departure from the health care facility. In this session, attendees will gain insight into one hospital's innovative approaches to addressing SDOH needs.

Learning Objective: Describe how to bridge the gap of unmet social needs of hospitalized patients through a hospitalist health care model utilizing an innovative program.
