### **Board and Governance Best Practices**

In this session, Karma Bass will share insights into the governance practices that set the nation's top health care boards apart from the rest. Drawing from her more than 20 years of experience in strategic planning, health care policy and board effectiveness, Bass will explore the key practices that distinguish high-performing boards and how they make the transition from good to great. Participants will learn practical tips for enhancing their board's effectiveness, improving decision-making and fostering a culture of collaboration and accountability. Whether you're looking to elevate your board's performance or optimize governance strategies, this session will provide actionable guidance to implement immediately. Discover what goes on in the best healthc are boardrooms and how to apply these lessons to your organization.

### Legal and Ethical Considerations in AI Health C are Applications

Attendees will explore the key legal and ethical considerations of using AI in health care. With AI rapidly transforming the industry, understanding compliance with regulations like HIPAA and maintaining ethical integrity is essential. Susan Frew, AI expert and entrepreneur, will provide practical insights into navigating legal challenges ensuring patient privacy and fostering trust in AI-driven health care solutions. Participants will leave with actionable knowledge on how to implement AI responsibly while promoting transparency and accountability.

### **Empowering Rural Communities Through Meaningful Engagement**

The session will focus on how rural communities can engage in meaningful conversations around health equity, using examples from Kansas to reduce stigma and misconceptions. Drawing on the successes in Cowley County, Yazmin Wood will highlight how the local community foundation has brought together diverse partners to tackle complex issues, such as teen suicide, which might not immediately come to mind when discussing equity. She will discuss the process of fostering community involvement and share how a data walk—an interactive, visual storytelling tool—can help people explore these issues in a hands-on, digestible way. Participants will have the opportunity to ask questions and explore how they might apply this approach in their communities.

### **Eggs and Issues Breakfast**

This session will focus on key issues impacting the health care sector including ongoing advocacy efforts, proposed legislation and the challenges and opportunities presented by the Kansas Legislature. Tara Mays will provide an update on the latest policy developments, share insights into legislative strategies and discuss how health care professionals can actively engage in advocacy to influence change. Attendees will gain a deeper understanding of the current legislative environment and the critical policy decisions shaping health care in Kansas. This session offers a valuable opportunity for participants to learn how they can become more involved in advocating for health care priorities at the state level.





### **Strengthening Health Care Governance: Best Practices for Hospital Boards**

This panel discussion will explore the unique challenges and opportunities health care organizations face in building and sustaining strong governance practices.
