#### **Clinical and Nonclinical Strategies in Swing Bed Management**

This session explores both clinical and operational strategies for effective Swing Bed management. Forvis Mazars will examine how cost report data can inform decision-making and highlight the financial considerations tied to Swing Bed utilization. Participants will gain a deeper understanding of how to align patient care priorities with financial sustainability, optimize admissions and resource use, and strengthen long-term program outcomes.

Objective: Identify strategies to support effective and sustainable Swing Bed management from both clinical and financial perspectives.

#### **Kansas TEAM Update**

This session will provide a focused update on the upcoming Transforming Episode Accountability Model (TEAM), a new mandatory CMS initiative launching January 1, 2026. Designed to advance value-based care, TEAM includes key changes that will impact surgical episode payments, post-acute care coordination, and potential use of services like Swing Bed. Findley will highlight key model components like: model design, SNF waiver expansion, quality reporting and strategies for working with model participants.

Objective: Identify key components of the Transforming Episode Accountability Model (TEAM) and describe the potential impact on rural hospitals and post-acute care services.

## Using Al Wisely: Balancing Innovation and Cybersecurity in Your Swing Bed Program

Artificial Intelligence offers powerful tools to streamline documentation, improve efficiency, and support decision-making in Swing Bed programs—but it also introduces new cybersecurity risks that cannot be ignored. This session will help you navigate the responsible use of AI in healthcare settings, with practical strategies to protect patient data, avoid common pitfalls, and maintain compliance. Learn how to leverage available resources while building safeguards that ensure your Swing Bed program remains secure, efficient, and resilient.

Objective: Apply AI tools in Swing Bed settings while maintaining cybersecurity and regulatory compliance.

# Understanding the Role of the Long-Term Care Ombudsman: Discharge Reporting Requirements Haely Ordoyne, Kansas State Long-Term Care Ombudsman, Office of the State LTC Ombudsman

As hospital discharge planning and care coordination grow more complex, providers often face confusion surrounding reporting requirements particularly when it comes to swing bed discharges. In this session, Kansas State Long-Term Care Ombudsman Haely Ordoyne will provide important updates and clarity around when and how to report patient discharges, especially in cases involving unplanned or involuntary transitions. Drawing from real-world examples including questions raised at previous KOSCP conferences Ordoyne will explain the role of the Ombudsman's office, review key reporting expectations, and offer guidance to help eliminate persistent misunderstandings among discharge planners and care teams. This is a valuable opportunity to hear directly from the Ombudsman and ensure your processes align with current guidance. Attendees are encouraged to bring questions and concerns, as this session will also serve as a listening opportunity to inform future education and outreach efforts. Do not miss this essential discussion on improving care coordination and regulatory clarity across Kansas hospitals.

Objective: Identify reporting requirements related to hospital discharges for swing bed patients and accurately apply current guidance from the Kansas Long-Term Care Ombudsman's office to support compliant and patient-centered care coordination.
